### What information we collect, use, and why

We collect or use the following information:

- Names and contact details, so we may update participants on outcomes of the project and any updates to the terms of this privacy notice.
- Addresses, to send out sample kits to participants who opt in to this part of the project.
- Location data, to provide information about the spiders photographed or collected as part of participation in this project.
- Recorded images, such as photos. The project basis is to investigate how
  Flower crab spiders are interacting with their plant community, thus it is
  dependent upon the submission of photos.

## Lawful bases and data protection rights

Under UK data protection law, we must have a "lawful basis" for collecting and using your personal information. There is a list of possible <u>lawful bases</u> in the UK GDPR. You can find out more about lawful bases on the ICO's website.

Our lawful bases for collecting or using personal information for **research or archiving purposes** are:

Public task – we have to collect or use your information to carry out a task laid down in law, which the law intends to be performed by an organisation such as ours. All of your data protection rights may apply, except the right to erasure and the right to portability.
